



## ELLIOT SPRINGS DISPLAY VILLAGE COMPETITION – VISIT STAMP & WIN – TERMS & CONDITIONS

1. The Promoter is Lendlease Communities (Australia) Pty Limited ABN 88 000 966 085 of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000. Contact number is 1300 739 839.
  2. Only residents of Australia aged 18 of age or older (Participant) are eligible for the Competition.
  2. The following person(s) are ineligible to enter the Competition:
    - a) employees of:
      - I. the Promoter; and
      - II. the Promoter's related bodies corporate (as that expression is defined in the Corporations Act 2001 (Cth)) and associated agencies, companies and contractors; or
    - b) members of the Immediate Families of the employees referred to at paragraph 3(a).
- Immediate family** means any of: a spouse or domestic partner, ex-spouse or ex-domestic partner, de-facto spouse or ex-de-facto spouse, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or first cousin.
3. The Competition commences at 8 am on Saturday 19 August 2023 and closes at 9am on Sunday 29<sup>th</sup> October 2023 (**Competition Period**). The Promoter may extend the Completion Period at its sole discretion (**Extended Competition Period**). Details of any Extended Competition Period will be posted on the Elliot Springs Facebook page in these terms and conditions to the Competition Period include any Extended Competition Period, where applicable.
  4. To enter you must visit the Elliot Springs Sales & Information centre and pick up the Visit, Stamp & Win passport. During Competition Period, you must visit the display homes of at least four different builders in the Elliot Springs Display Village, collecting stamps in your passport from each home visited. In addition, you must name your favourite home design and why and record your answer in the passport. Once complete, you need to drop the passport back to the Elliot Springs Sales Centre before the end of the Competition Period to be eligible to enter the draw. Only one entry per person will be accepted.
  5. For the Participant to be eligible to compete in the Competition, each of the following must be satisfied. The Participant must enter the Competition:
    - a) within the Competition Period;
    - b) in the strict manner specified on the entry form for the Competition; and
    - c) by the method specified on the entry form for the Competition.
  6. The first fully completed and eligible entry drawn will win a \$500 Visa Gift Card. The second fully completed and eligible entry drawn will receive a \$200 Visa Gift Card. The third fully completed and eligible entry drawn will receive a \$100 Visa Gift Card. Winners will be drawn at random.

  9. A judge's decision is final and no correspondence will be entered into.
