

## **Jordan Springs Neighbour Day 2022 Competition Terms & Conditions**

- 1. The Promoter is and Maryland Development Pty Limited, ACN 069 368 896. Only residents of Jordan Springs aged 18 years of age or older (Participant) are eligible for the Competition.
- 2. Only residents of Jordan Springs aged 18 years of age or older (Participant) are eligible for the Competition.
- 3. The following person(s) are ineligible to enter the Competition:
  - a. employees of:
    - i. the Promoter; and
    - ii. the Promoter's related bodies corporate (as that expression is defined in the Corporations Act 2001 (Cth)) and associated agencies, companies and contractors; or
  - b. members of the Immediate Families of the employees referred to at paragraph 3(a). "Immediate family" means any of: a spouse or domestic partner, ex- spouse or ex-domestic partner, de-facto spouse or ex-de-facto spouse, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or first cousin.
- 4. The Competition commences at 9am (AEDT) on 11 March 2022 and closes at midnight (AEDT) on 27 March 2022 (Competition Period). The Promoter may extend the Completion Period at its sole discretion (Extended Competition Period). References in these terms and conditions to the Competition Period include any Extended Competition Period, where applicable.
- 5. To enter, one member of the eligible household must complete the form provided on the Jordan Springs website during the Competition Period. The form will require you to:
  - a. provide contact details, including full name, contact number and email, property address as part of the competition;
  - b. describe how a neighbour has helped you out in a big or a small way at Jordan Springs (50 words or less); and
  - c. if you are notified as a winner, agree to for your neighbour story to be shared on Jordan Springs social media and newsletters.

Each eligible household can only submit one entry.

- 6. For a Participant to be eligible to compete in the Competition, each of the following must be satisfied. The Participant must enter the Competition:
  - a. within the Competition Period;
  - b. in the strict manner specified on the entry form for the Competition; and
  - c. by the method specified in paragraph 5 above and on the entry form.
- 7. The winning submissions will receive 1 of 5 grazing boxes valued at \$100 from Yum Artisan Creations Jordan Springs.
- 8. Judging will take place between 28 March 2022 and 29 March 2022. The winners will be notified via phone or email by 29 March 2022

- 10. Each entry will be individually judged based on merit. A judge's decision is final and no correspondence will be entered into.
